Communication Skills: Detect & Defeat the Most Common Communication Snafu's *

Whether managing others, working in a cross-functional project team, or providing internal/external client support, excellent communication skills are crucial for all employees at any level within any organization and it doesn't have to be filled with drama. In order to make communicating effortless and drama free, you'll have to put considerable thought and effort into your style and that of others to make the type of impact required for your effectiveness.

- 2. Identify your communication style and the style of others for greater effectiveness
- 3. Practice practical tools and techniques to add impact to your communication

Supporting Children with Medical Needs *

Erin Pemberton, Summit County Board of Developmental Disabilities

Come join me as we explore the world of supporting all children in group settings. Participants will learn in greater detail what licensing says about documentation, what training needs to occur before the child starts and then can interact with several different training modules with hands on experience. We will look at sample forms completed correctly and dig deeper on forms that have some mistakes to better understand how to remain in compliance. Participants will dig deeper about their feelings and bias and how to tackle them with other professionals and parents. We will look at why families choose not to disclose information about a child diagnosis or education plan. Finally, we will look at how professionals feel when they have tried everything and they still fail to be able to serve the child.

Learning Outcomes:

- 1. Strengthen ability to support children with medical needs in the classroom setting by learning how to get beyond personal fear, revisiting licensing rule, bias, and family fears
- 2. Participate in hands on experience with a few different pieces of medical equipment, including tube feeding, AFO's, EpiPen's, Inhalers, thickener and insulin

It's in the Details: Using Practice - Based Coaching to Support Curriculum Fidelity *

This session is a continuation of the partnership between STGi and OHSAI to support Advanced Practice Based Coaching, building upon the PBC Leadership Academy, Coach Training, TLC, and Advanced PBC sessions (previous participation in these is recommended, however, not required). This session will support you as a coach by exploring a specific topic relevant to you in your role- curriculum fidelity; identifying resources and strategies specific to our topic, and then putting it into practice what we learned via scenarios, videos, opportunities to ask questions and network with other programs. If you are a coach or someone that supervises or supports coaching implementation this session is for you.

- 3. Identify teaching practices and strategies that support curriculum fidelity

The Importance of Financial Literacy: Tools and Resources to Improve Financial Wellness Now, and Into the Future *

This session will aim to educate you on the importance of pursing financial literacy, as well as provide the resources and tools that can help you achieve and maintain financial wellness.

PITC: Facilitating Learning and Development with Infants: Brain Development

This session is the first in a 3-part series in which the content of the Program for Infant Toddler Caregiving (PITC) Module 3: Facilitating Learning and Development will be delivered. Topics to be covered in future sessions will include: Discoveries of Infancy, Language Development, and Communication and Culture. Infant and Toddler caregivers have THE most important job in any early childhood setting, because they literally are building the brains of the infants and toddlers that they care for. Through individualized experiences, interactions and environments, these children thrive and connections in their brains are solidified. This session outlines key aspects of early brain development and presents major findings from recent research.

Learning Outcomes:

- 1. Articulate how the brain is built from birth to age 3
- 2. Connect the development of the brain to the experiences, environment and relationships that the infant or toddler encounters
- 3. Practice activities that can be done to support brain development

Leading by Exemplar: Lessons from Head Start Programs is a synthesis of findings from an in-depth analysis of high-performing Head Start programs. This session will give participants the opportunity to discuss work with others from their program to identify the practice that could be most useful to their program and begin to create an action plan for how to adapt or adopt it.
